NOTE : What the section of IPC says :

1. **Sec. 153 (A) of IPC** : Promoting enmity between classes - Cognizable offence - Non-bailable - punishment – imprisonment for 3 years
2. **Sec. 332** : Voluntarily causing hurt to deter PUBLIC SERVANT from his duty – Cognizable offence – Non-bailable - Punishment imprisonment for 3 years
3. **Sec. 435** : Mischief by fire or explosive substance with an intent to cause damage – Cognizable offence – Non-bailable - Punishment imprisonment for 7 years
4. **Sec. 436** : Mischief by fire or explosive substance with intent to destroy a house. Cognizable – Non-bailable - Punishment life imprisonment
5. **Sec. 120 B** : Criminal conspiracy to commit an offence – Cognizable – Non-bailable – Punishment 2 years to death depending up the offence.
6. **Sec. 307** : Attempt to murder – Cognizable – Non-bailable – Punishment – imprisonment for 10 years or life imprisonment
