**Sub : Nayeem case – Constitution of S.I.T. – Delay and inadequate action taken by S.I.T. – Instructions to expedite the investigation of the case and take action against the persons including Politicians, Police involved in the criminal activities of Nayeem – Reg.**

Forum for Good Governance submitted a representation in July 2019 to H.E. the Governor with a request to instruct the authorities to complete the investigation fairly and quickly so that the persons involved get the punishment.

Our representation was forwarded in August 2019 to Chief Secretary for necessary action. In the office of Chief Secretary our representation was not brought to the notice of Chief Secretary, the Peshi forwarded it to Home department. In Home department A. S. has forwarded to D.G.P. The office of D.G. inturn has sent to I.G.P. North Zone (head S.I.T.) and is lodged there, when our complaint is against S.I.T. for its inaction what the use of again sending it to S.I.T. No senior officer is reading our representation. It is being tossed from one office to other office.

The way our representation is treated reminds me a Telugu saying (దున్నపోతు ఈనిందంటే దూడను కట్టేయమన్నాడట అన్న చందాన ఉంది). I am sorry for using unparliamentary language, it is not against any body but against the system. In our representation to H.E. the Governor we flagged certain specific issues which are pointed and should have been ordered for enquiry.

Here it is pointed out that it is not a simple case of a gangster. It is a case of Police, Politician and criminal coming together and committing atrocities on innocent people. We have a reason to believe that hundreds of crores of rupees were unearthed in Nayeem house, two counting machines were pressed into service for accounting them but only Rs. 3,74,660 was recorded. When two counting machines process into service in a day they might have counted more than Rs.200 crores, so what happened to this money? Nayeem acquired (by force) more than 1000 Ac. of land with the active Co-operation of Police, Politicians, Revenue and Registration officials. Since last 4 years the progress in the case is very little. We request the Chief Secretary to handover the case to C.B.I. as the present S.I.T. is not able to handle the case.
