Sub : School Education department – Large scale fraud in appointments and promotions of Teachers by submitting fake certificates – Government not pursuing the case – Request for speedy action in the matter – Reg.

In the year 2008 and 2009 about 878 Teachers got jobs and some working Teachers got promotions by submitting fake degree certificates issued by some non existing universities and universities which are not competent to issue certificates and got jobs and promotions. The working Teachers who were overlooked approached Lokayukta. The Lokayukta in their order dated 2-4-2013 ordered to entrust the case to CBCID and expedite inquiry. As directed by Lokayukta the case was handed over to C.B.C.I.D. and District Education Officers were instructed to frame charges that produced fake certificates and file criminal cases against them.


Meanwhile the fake certificate Teachers approached the Hon'able High Court. The Court in their interim order dated 9-4-2014 directed the Government to continue the fake Teachers in the same post pending further orders.

After 12 years of commission of offence, C.B.C.I.D. inquiry is not completed and no efforts were made by Education department to get the stay issued in 2014 is vacated. We have a reason to believe that some officials in the O/o Commissioner of School Education have some soft corner to these 878 fake Teachers and intentionally dragging on the case. During last 5 years we have submitted number of representations to Commissioner School Education, he did not take any action. Teachers are supposed to impart knowledge and teach moral values to children. We cannot keep the future of our children in the hands of fake and immoral Teachers.

Forum for Good Governance requests H.E. the Governor to kindly instruct the Chief Secretary to obtain inquiry report of C.B.C.I.D. and also to take steps for vacation of stay orders of Hon'able High Court and action initiated on the fake Teachers.
